#### **Booking Rules & Regulation :**

- For Any Fixed Departure tour, a Minimum of 20 Heads is required.
- Below 20 heads, Only customized Packages are available.
- Seats are normally reserved on payment of 50% of total amount.



- Full and final payment is to be made before 30 days from the date of journey. If it is not paid before at least 15 days from the date of journey a compensation of Rs.100/- per head per day will be charged till not paid as a late fine.
- Bus / Car seats will be reserved on the first cum first served basis. During journey of any tour, it will be rollover basis seat allocation.
- No Choice of Seat will be accepted. The parties are requested to check their original tickets before the journey to avoid inconvenience during journey. The company (mercury tour operator/MTO) will not be liable for any dispute during journey.
- Please Book your Package at least 90 days before from the date of journey.
- Company(mto) will not be liable for any Kind of Bandh, Political disturbance, Natural Calamity during the tour . Due to this reason if the duration of tour is extended(as per the tour schedule)the extra cost has to be borne by the party.
- Manager or any company person will not undertake any liability towards any loss, damage of Life /Property, Any breakage of any belongings whatsoever of the tourist caused by any accident/theft/ robbery or any other towards happening during the tour.
- Family wise room 2 or 3 person in a Double Bedded room. Mattress on floor may be provide if possible . The Charges for the Mattress, Pillows, Blankets, Room heater will be charged extra and to be borne by the party. The Rooms at Kedarnath/Badrinath/ Amarnath/Gangotri/Jamunotri/Gourikund / Sitapur will be Dormitory Basis.
- Every Passenger should carry One Middle Size Suitcase/ Hand Bag (Per person One bag). carrying Cost/ Coolie cost/ Porter Cost for Extra Luggage will be borne by the passenger.
- Full and Final Payment should be done in our Head Office only. No one from our office will collect the full and final payment from any customer from their residence /office.
- 5% GST on the total package amount is applicable
- 5% TCS (upto 10 lacks in a financial year, above 20%) refundable during tax filling
- Insurance coverage is compulsory by paying extra charges.



- If the tour is Canceled by us for any reason then the party may switch over to any other tour or may avail any tour within a span of one year and the payment will be adjusted in the next tour within the same duration after that payment will be non adjustable . No cash will be refunded.

### **International Tour Cancellation Policy**

- Mercury Tour Operator reserves the right to revise or cancel any tour booked by the Traveller without providing any specific reason. Such revisions or cancellations may occur due to circumstances beyond our control. In such instances, we will offer alternative tour dates or tours, or the option for Travellers to proceed as individual travellers rather than as part of the original group tour. If the alternative dates or tours are not acceptable to you, or if you opt not to travel as individual travellers, we will refund the amount paid by you, excluding any incurred costs, within forty-five days from the date of revision or cancellation. However, we will not be held responsible or liable for any reimbursement, damages, substantial loss, or refund of other expenses incurred by you.
- Should you wish to cancel your booking, you must provide written notification to us. This notification will only be considered received upon our receipt of your letter, as we can only act upon receipt. Any claims must be directed to you after deducting the cancellation charges as outlined herein.
- If any cancellation is related to political reasons, communal riots, pandemics, or natural calamities and disasters, the customer is responsible for the cancellation charges. Mercury Tour Operator is not liable for such issues and will not refund any advance money given by the customer.
- The following cancellation charges shall apply irrespective of the reason for cancellation. You understand and acknowledge that these charges represent a genuine pre-estimate of the damages that we will incur due to cancellation. These charges are considered liquidated damages in legal terms and are payable without proof of actual damages. You agree not to dispute such deductions or demand proof of actual damages. Mercury Tour Operator is entitled to charge the following cancellation fees to the Travellers / B2B agents.
- Minimum Cancellation Charges for International Tour anytime after booking is 30% of the tour Value + Visa Cost Incurred + Insurance cost incurred + Ticket Cost



- 75 days prior to departure: Rs. 15,000/- + visa charges (if applicable) + Ticket cancellation charges (if applicable)
- 74 to 60 days prior to departure: 30% of the package Cost
- 59 to 45 days prior to departure: 40% of the Package Cost
- 44 to 30 days prior to departure: 65% of the Package Cost
- 29 days or Less prior to departure: 100% of the Package Cost
- 'No Show' on the tour: 100% of the Package Cost.
- In case of visa refusal, Mercury Tour Operator will apply cancellation charges consisting of the visa cost, ticket cancellation charges (if applicable), and a service charge of Rs. 15,000/-. This applies under the condition that the visa refusal occurs at least 75 days before the scheduled journey date; otherwise, standard cancellation policies will be applicable.
- Upon visa rejection, the cancellation will be considered effective from the date of intimation of such rejection. Please refer to our Visa Guidance section for further details.
- If a Schengen visa or any other visa is refused subsequent to obtaining a UK visa, normal cancellation charges will be applicable as outlined in our terms & conditions. Note that Sundays and holidays will not be counted in the calculation of cancellation days.
- In instances where visa delay or refusal necessitates the cancellation or deviation of the tour immediately before the original departure date, passengers will be responsible for bearing the associated cancellation or re-booking charges.
- Failure to timely remit tour costs or any other booking default may result in Mercury Tour Operator treating such occurrences as a cancellation by you. In such cases, cancellation charges will be determined based on the date of issuance of the cancellation notice.
- In the event that no formal notice of cancellation is issued by Mercury Tour Operator, but payment defaults or other defaults persist until the departure date, the booking will be deemed as cancelled by you without prior notice, incurring the highest cancellation charge. By booking with us, you expressly agree to adhere to these terms and conditions.
